

Minutes of the Town of Lee Cemetery Trustees

May 12, 2023

Cemetery Trustees present: Peter Hoyt, Chairman; Donna Eisenhard, Bookkeeper and Jeff Liporto.

Others present: None.

1. Chairman Hoyt called the meeting to order at 3:30 p.m.
2. Chairman Hoyt presented a map of where burials are placed on the Keniston-Wilkie plot in the old section. As several family members are buried there, it was important to note the two graves assigned for Richard Levis and Robin Fimlaid for the future.
3. Mrs. Eisenhard asked if Mr. Hoyt was successful in locating a vendor for British Veteran Memorial flags. He stated he has and six had just been delivered. One goes on the Keniston-Wilkie plot for Derek Seeley, one on the Elaine Gauthier plot for Malcolm Paterson and one by the gate next to driveway 2 along the road.
4. Mrs. Eisenhard stated the VFW set a date of May 15th to place Veteran Memorial flags at Lee Hill and Old Parish cemeteries. This date may be changed the Commander. No information has been received to date but Chairman Hoyt said h will ensure they can get into the cemetery shed to get the flags needed.
5. Chairman Hoyt stated the diseased and split maple in Lee Hill Cemetery is scheduled to be removed by Orion Tree Service soon at a cost of \$2000.
6. Chairman Hoyt stated Gary Cousen of Hillside Landscaping will be applying fertilizer and grub control shortly at Lee Hill Cemetery.
7. Mrs. Eisenhard asked if the water spigot hose extenders had been installed yet. She said one is a bit too long and needs to be shortened to match the others. Chairman Hoyt said he would take care of that.
8. Chairman Hoyt stated the Public Works Department has been extremely busy with burials held over from winter plus new burials that have been occurring.
9. There being no further business, meeting was adjourned at 4:20 p.m.


